Little Mermaid Lead Actor/Guardian Agreement

In the event I am cast in Kre8ive Fine Arts Academy's production of *the Little Mermaid*, I agree to adhere to the following standards:

- 1. I will attend all rehearsals unless excused by the stage manager or director.**
- 2. I will dress appropriately, and I understand I will not be allowed to rehearse in bare feet nor sandals.**
- 3. I will be respectful to my directors, stage managers, crew members, volunteers and fellow actors.**
- 4. I will be prepared. I understand that being prepared means learning my music and lines by the "off book" date given on the production calendar, bringing my libretto, a pencil, and water to rehearsals, and rehearsing blocking and choreography outside of the designated rehearsal time.**
- 5. I understand that all rehearsals for the production are CLOSED rehearsals. This means that only cast and crew members of the show are allowed inside of the rehearsal room/venue during the rehearsal hours. No parents, friends, etc. are allowed in the rehearsal spaces during rehearsals.**
- 6. I agree to represent the Kre8ive Fine Arts Academy and our production in a responsible, positive and respectful manner both in and out of rehearsals.**
- 7. I understand that cell phones and other electronic devices are to be turned off and kept offstage during all rehearsals and performances.**
- 8. I understand that the Kre8ive Board and Kre8ive Team will not tolerate any forms of bullying among the cast. I understand that I/my student may be released from the show if there are repeated occurrences of bullying.**
- 9. I will willingly follow the Covid prevention guidelines set forth by the Kre8ive Board and Team and I understand that these guidelines may change quickly as they follow the recommendations of the CDC and the Illinois Department of Health.**
